



Terms of Use

Effective: August 16, 2021

You may revoke your authorization for us to access your utility data at any time.

3. License Fees

There are no fees for your use of this website. However, the data we collect may be used for services as described above which do incur fees. Pricing for these fees will be jointly agreed upon by both parties.

As noted in section 1, you may revoke your authorization for us to access your utility data at any time. Please note that in the case of M&V and performance monitoring, revocation of access may impact incentive or other payments you are receiving for the installation of the monitored energy efficiency or distributed generation project.
